ANSWER WITH EXPLANATION





1. Part (b)

Correction: Replace has with have. Explanation: The relative pronoun who refers to students, which is plural, so the verb should also be plural (have).

2. Part (b)

Correction: Replace were with was. Explanation: When neither...nor is used, the verb agrees with the nearest subject (minister), which is singular.





3. Part (c) Correction: Replace since with for. Explanation: Since is used for a specific point in time, while for is used for a duration.

4. Part (b)

Correction: Replace provide with provides. Explanation: The subject is The book, which is singular, so the verb must agree in number.





5. Part (b) Correction: Replace must with had to. Explanation: In reported speech, must changes to had to.

6. Part (d) No error.Explanation: The sentence is grammatically correct.







7. Part (a)

Correction: Replace **to accompany** with **on accompanying**. **Explanation:** The verb **insisted** is followed by **on + gerund**.

8. Part (c) Correction: Remove time. Explanation: The phrase within one month's time is redundant; within one month is sufficient.

9. Part (b)

Correction: Remove **for** after **demanding**. **Explanation:** The verb **demand** does not require a preposition.

10. Part (c) Correction: Replace than with to. Explanation: The correct phrase is prefer to shop online to offline.







11. Part (a) Correction: Replace was with were. Explanation: In conditional sentences, the subjunctive mood is used, so were is correct.

12. Part (d) Explanation: The sentence is grammatically correct.





13. Part (b)

Correction: Replace of with on. Explanation: The correct phrase is dependency on, not dependency of.

14. Part (d) Explanation: The sentence is grammatically correct.

15. Part (b)
Correction: Replace has with had.
Explanation: The main verb is in the past tense (complained), so the subordinate clause should also be in the past tense.
